# Exchange Visit by the Chairmen and Secretaries (20 members) of selected BMCs of Telangana

From 06-05-2016 to 07-05-2016 At

### Korangi BMC of Tallarevu Mandal and Venkateshwara Ayurveda Nilayam, Chintaluru, East Godavari District, Andhra Pradesh

#### **Background**

The NBA and Telangana State Biodiversity Board under UNEP-GEF-MoEF&CC-ABS project jointly conducted a comprehensive Exchange visits at Korangi BMC of Tallarevu Mandal and Venkateshwara Ayurveda Nilayam, Chintaluru, East Godavari District, AP to the Chairmen and Secretaries (20 members) of selected BMCs of Telangana State constituted under project for learning the best practices of conservation of biological resources, preparation of PBRs, ABS mechanism, and importance of local seed varieties along with the importance of seed registration etc.

Following are the major events carried out during the visits.

#### Visit to Venkateshwara Ayurveda Nilayam, Chintaluru

The team of Chairmen and Secretaries along with the TSBDB staff visited the Venkateshwara Ayurveda Nilayam, Chintaluru. The Managing Director Dr Shreerama Murthy explained the processes of manufacturing various Ayurvedic Medicines. He explained about sources of medicinal plants in that area. He told that the Abs agreement entered with APSBDB

for accessing the Biological Resource from Korangi BMC for access to Biological resource "Adonda (Coccinia cordifolia)" seeds.

Then the team visited the local nurseries for understanding the breeding of local varieties and hybrid varieties of horticultural species and values of medicinal plants.









#### Visit to Korangi BMC

The team has visited the Korangi BMC of Tallarevu Mandal, East Godavari District. The BMC Chairperson of Korangi, Shri Rani explained about the agreement made with M/s Venkateshwara Ayurveda Nilayam (M/s VAN), Chintaluru. She explained about the Biological resource "Adonda (Coccinia cordifolia)" seed were available at river side as weed. Then the BMC passed a resolution for fixing the levy fee as 1000/- per ton.

The chairperson of BMC explained about the utilization of LBF for conducting the awareness programmes, meetings and for purchasing the drinking water dispenser etc. The participants from Telangana interacted with them and had good conversation with them regarding the activities of the BMC.

Then the team has visited local Korangi Sanctuary and seen the Mangrove forest area. The team interacted with the FRO Mr. Rajani Kumar explained about the species diversity available at the mangrove forest.









The visit and interaction with BMC members of these villages have immensely benefited the visitors to gain knowledge on relevant issues.
